Fees and Payment Arrangements

Application Fee
A non-refundable application/processing fee of AED 210 (inclusive of 5% VAT) is payable by all applicants upon submission of their application.
Tuition Fees and Financial Obligations
- Tuition fees are payable each academic semester in accordance with the payment deadlines announced by the University. - The University publishes tuition fees, additional charges, and payment deadlines on the official Student Accounts Office webpage. These may be updated from time to time in accordance with the University's approved policies.
Additional Charges
Where applicable, students are responsible for: Any currency exchange differences and charges imposed by the student's bank or payment service provider.
Payment and Refunds
- Students are responsible for paying all tuition fees and any other applicable charges by the published payment deadlines. - Students wishing to withdraw from the University or from one or more courses must complete the official withdrawal procedures through the UAEU e-Services Portal. - Any tuition fee refund, where applicable, will be processed in accordance with the University's Refund Policy in effect at the time the withdrawal request is submitted.
