<u>Abstract</u>

The spread of the Corona virus has clearly affected the work of public utilities in the country, disrupting some of them and modifying the way others work, as the spread of the pandemic has led to the creation of new methods and means that were not familiar in the functioning of public utilities. The most important of these means is education and remote litigation, which is done through modern means of communication, including the Internet. Since the health facility is one of the most vital public facilities, both the United Arab Emirates and Jordan have been keen to continue its work regularly and steadily during the pandemic, by taking many measures and procedures that have worked to continue its work. The researcher dealt with the subject of the health facility between the requirements of the public system and the principle of continuity of the public facility in exceptional circumstances "a comparative study" through two chapters preceded by an introductory study in which it dealt with the principle of continuity of the health facility and the requirements of the public system.
