Deadlines for the Settlement of Tuition & Fees for Spring 2017

- 1st Payment Deadline (50% of total tuition fees) on, **29 January 2017**
- 2nd Payment Deadline (remaining 50% of total tuition fees) on, **23 February 2017**

Tuition Payment Installment Plan

- To arrange a tuition payment installment plan, students must apply at the SAO before **09 February 2017**. If you were entitled to an installment plan in the previous semester, you must apply again for the current semester
- Non-payment of total tuition fees on or before **14 April 2017** will result in a hold being placed on registration and records. A hold means that you will not receive course grades until you pay your fees. It also means that you will not be able to register for courses in the next semester until payment is made. Unfortunately it may also mean the forfeiture of grades and credits earned during the semester.
- **Sponsored students**
Students whose tuition charges are paid for or guaranteed by a sponsor must submit a valid official letter of financial agreement from the sponsor no later than **23 February 2017**, or risk having their registration for Spring 2017 cancelled.
